- **NO MEET DAY ENTRIES ACCEPTED.**
- Entry Deadline: received by 2/11 or online by 2/13 at noon.
- Individual: \$20 first event, \$15 each additional event.
- Relays: \$30 per relay, day of meet only, by 2:00.
- Doors open and check-in starts at 9:30.
- Spike length inspection and certification done at check-in and bib pick up.
- Age groups may be combined in some events if entries warrant.
- All rules, including hurdle heights and implement weights, according to USATF Competition Rules.
- Vertical jumps will start at a low height and move upward; bars will not be lowered after events begin.
- USATF-NJ and USATF-non-NJ will be mixed seeded.

AGE GROUPS: Open: 14+ for women, 16+ for men;
Masters: 5 year age groups starting at age 30.

AWARDS: For each age group and each gender in each event.

- Medals to top 3 USATF New Jersey.
- Medals to USATF-non-NJ athletes if in the top 3.
- Patch to winning USATF-NJ athletes (one patch per athlete).

DIRECTIONS: From the North: Garden State Parkway (GSP) South to Exit 82 for Route 37 East. Continue on Route 37 East to 2nd traffic light (Hooper Avenue). Take jug handle over Route 37 and go north on Hooper Avenue. After 7 traffic lights, the Sports Complex will be on the right. **From the South:** Take the Garden State Parkway North to Exit 83 for Pleasant Plains. Make 2st right onto Route 571 (Indian Head Road). Go to the 4th light (Hooper Avenue). Take jug handle after the light. Go north on Hooper Avenue. After 4 traffic lights, the Sports Complex will be on the right. **From the West:** Take Route 70 East to Route 37 East. Continue on Route 37 East under the Garden State Parkway. At the 2nd light after the overpass take the jug handle over Route 73. Go north on Hooper Avenue. After 7 traffic lights, the Sports Complex will be on the right.
